

Funding Guidelines

This application is for immediate philanthropic aid raised through for those directly impacted by the collapse of the Champlain Towers South Condominium on Thursday, June 24, 2021. Support Surfside is establishing a Steering Committee to oversee the balance of funds raised which will include opportunities for public input, but understanding the urgency of needs in this moment, we are dedicating funds for initial and immediate assistance.

Due to the devastation caused by the building collapse, our hope with this application is to minimize the burden on the applicants while still ensuring that the funds go directly to the individuals impacted.

Gifts in the amount of \$5,000 per family impacted will be made available to the designated representatives of the following groups:

- 1. Survivors of the Champlain Towers South collapse (i.e. in the building at the time of the collapse)
- 2. Current residents of Champlain Towers South but not present at the time of collapse
- 3. Immediate family members or legally appointed representatives of missing or deceased individuals

Appropriate documentation will be required to verify applicant identity and proof of residence or ownership. If legal heirs are in dispute regarding who will apply for and receive the payment, they will need a court of law to determine who will be the legally appointed representative to receive this funding and will need to provide proof of legal entitlement to these funds.

FAQs

- 1. I already received money from Support Surfside from the table at the Family Assistance Center. Am I eligible to receive these funds? Yes! This is in addition to any financial support already received assuming you meet the above guidelines.
- 2. I am the legal owner of the unit but was not the current tenant can I apply for funds?

 No, at this time, we are not accepting applications from unit owners that had other people residing in the building at the time of the collapse.
- 3. I traveled in and am awaiting news of a loved one. Can I apply to cover my travel related costs?

 If you are the designated representative of an individual or family that was on site during the collapse, you may apply. Unfortunately, other family and friends may not apply for this round of funding.
- 4. Are their restrictions on how these funds can be used?

 There are no restrictions on the use of funds received. The funds are considered a gift to help provide short term relief.
- 5. Will there be more funding available in the future from Support Surfside?

 Yes, additional funds will available t in the future. This current application and process will be used to provide short-term relief funding to the victims most impacted by the collapse. To oversee the balance of funds raised by Support Surfside, we are establishing a steering committee that will generate transparent guidelines and receive community input. Support Surfside has partnered with the National Compassion Fund (NCF), a subsidiary of the National Center for Victims of Crime, and a leading authority on how victims are compensated for loss, to assist with the development and implementation of a fund distribution program for the majority of funds raised through the Support Surfside Fund. A Local Steering Committee responsible for establishing the Fund distribution policy is in the process of being formed and a timeline for the next phase of funding will be available soon at www.supportsurfside.org.
